Release Agreement

In consideration of the sum set forth above, and the mutual obligation of the above parties involved in the Key West Boat Show and Nautical Flea Market (hereinafter referred to as the "Event") I, the undersigned, on behalf of myself and any corporation entity which I represent for their participation in the Event, if any, and on behalf of all my employee, agent, volunteers, and the corporation's employees, agents and volunteers, which are participating in the Event, or are otherwise present for the event, with the intention of binding myself and all others listed above, herein release, indemnify, discharge, defend and save and hold harmless the Key West Rotary Foundation, Inc. d/b/a Rotary Club of Key West, the City of Key West, all other event sponsors, and their agents, respective officers, directors and employees (herein collectively referred to as "Sponsors"), for any liability, claims, losses, demands, actions, fines, expenses, costs, judgments, all foreseeable and unforeseeable damages whatsoever, whether for personal injury, bodily injury, (including death) or property damage arising during the Event or as a result of or due to participation in the Event. There undersigned, being fully aware of the risks and hazards inherent in participating in the Event, hereby voluntarily elects to engage in such activity and assumes all risks of loss, damage, or injury the administrators of the undersigned or those of any individual who the undersigned is signing on behalf.

The undersigned irrevocably grants to Sponsors the right to use his/her likeness in photographs, film or video for promotional use in any and all media. This release agreement shall extend to all claims, demands and causes of all action whatsoever arising wholly or in part from any act or omission of the Key West Rotary Foundation, Inc d/b/a Rotary Club of Key West, their officers, directors, agents and employees.

The undersigned further agrees not to vacate their assigned space prior to the conclusion of the Event, 5PM, EST, March 2, 2008. Failure to comply with either of these stipulations will result in the undersigned, or the undersigned's corporate identity, to be ineligible for any future Rotary Club on Key West sponsored events.
